

#### **Sustainable & Well Managed Forestry:**

West Fraser Europe Limited is dedicated to producing board from sustainable sources of wood only. All the wood we use comes from responsibly managed forests and/or post-consumer recycled wood. In addition, our manufactured products are from certified forests and/or come from legally sourced timber managed through our Due Diligence System (DDS). All our UK harvested roundwood is purchased in line with the current UKWAS requirements.

#### **Timber Industry & West Fraser:**

The UK Woodland Assurance Standard (UKWAS) is an independent certification standard for verifying sustainable woodland management in the UK that is used for chain of custody certification. This UK certification standard is designed to reflect the requirements set out in the governmental UK Forestry Standard and thereby the General Guidelines adopted by European Forestry Ministers at Helsinki in 1993, the Pan-European Operational Level Guidelines (PEOLG) subsequently adopted at Lisbon in 1998 and other relevant international agreements. All harvesting operations in the UK must comply with this standard. All our production sites hold ISO 14001:2014 Environmental Certification. West Fraser Europe Limited has implemented a Timber Procurement Policy as a commitment to the eradication of illegal timber.

Our Timber Procurement policy commitments are to not directly or indirectly be involved in the following activities:

- 1. Illegal logging or the trade in illegal wood or forest products
- 2. Violation of traditional and human rights in forestry operations
- 3. Destruction of high conservation values in forestry operations
- 4. Significant conversion of forests to plantation or non-forest use
- 5. Introduction of genetically modified organisms in forestry operations
- 6. Violation of any of the ILO (International Labour organisation) core conventions, as defined in the ILO Declaration on Fundamental Principles and Rights at work
- 7. Procurement of any forest products that have been purchased from countries under any UN government sanctions or timber sales that would financially support areas of conflict
- 8. Procurement of forest products that have been traded at some point by armed groups
- 9. Forest activities not complying with local, natural or international legislation
- 10. Procurement of products from; controversial sources, endangered and protected species including requirements of CITES (Convention on International Trade in Endangered Species).

#### **Timber Raw Material Supply Chain:**

We verify our suppliers through an approval process under our ISO 3<sup>rd</sup> party certification process and in compliance with Sarbanes Oxley Act (SOX). As part of this process, the country of origin, species and certification status is checked. All our supply agreements are set up as contracts on our computer systems to monitor each transaction over our calibrated weighbridge. Our self-billing system is checked for any source, or supplier discrepancies by our Timber Administration Team. Where a discrepancy is identified, our Compliance Team will carry out an investigation.

Where we purchase raw material from UK and Europe, our control systems and due diligence systems ensure that we identify, trace and monitor inputs for legal status throughout our compliance auditing systems. This document provides information to meet both the requirements for EUTR/UKTR for all products manufactured by West Fraser Europe Limited. We are now actively working forwards compliance with the requirements for EUDR (EU Deforestation Regulations) in preparation for the compliance date of December 2025 and are actively working with our supply chains to gather the additional information required including forest geolocation data.

All our timber raw material inputs are traceable through our supply chains back to the source of origin, either directly from the forest or via our approved wood recycling suppliers. Our board products are sold as either FSC Mix (Certificate No: SA-CoC-008109, Licence Number FSC-C012533 or 70% PEFC certified (Certificate No: SA-PEFC-CoC-008109) depending on product type. Our systems are audited annually by our 3<sup>rd</sup> party certification body, The Soil Association.

#### **Due Diligence & Monitoring:**

As part of our supplier onboarding process, we obtain evidence to meet the Supply Chain Act and Modern Slavery Act in line with our policies. We continually monitor all our supply chains, contract performance and supplier details for accuracy as part of our internal audit system. We routinely select loads and conduct a full trace back to the forest of origin as part of our audits. Any country source that has a specific risk will not be approved for supply contracts unless the supplier can demonstrate that risk mitigations are established, this may lead to a full audit by a Timber Technical Expert. Where non-certified inputs are approved these are subject to individual risk assessments on a purchasing contract by contract basis.



We actively monitor countries under UN sanctions or areas of conflict/potential conflict and do not procure any raw material from these areas.
